As you may be aware, Carmarthenshire County Council has commenced work on a Revised Local Development Plan (LDP) for the period 2018-2033. The Revised Local Development Plan will, upon adoption, replace the current Plan and be the basis for land use planning decisions.

I am pleased to inform you that the **Deposit Revised Local Development Plan (LDP)** has been published for consultation along with the following documents:

- Sustainability Appraisal (SA) and Strategic Environmental Assessment (SEA)
- Habitat Regulations Assessment (HRA)
- Caean Mynydd Mawr SAC Supplementary Planning Guidance
- Burry Inlet Supplementary Planning Guidance.

The consultation on the Deposit Revised LDP and the above documents will be between 29th January and 13th March 2020.

The Deposit Revised LDP sets out the land use policies and proposals including the allocation and use of land through to 2033. Comments on the published documents should be submitted in writing, preferably using our online consultation tools by no later than **4:30pm on Friday 13th March 2020**. There are a number of advantages to using our online consultation tools, not only will it assist us in adhering to the tight timescales we have, but you will be able to track progress of your comments in respect of the Deposit Revised LDP throughout the Plan preparation.
